Bids received in excess of the ABC shall be automatically rejected at the opening of the financial proposal. Interested consultant/bidder/s shall submit their bid proposal.

- 1. The HUDCC calls for the submission of one (1) original and two (2) duplicate copies of eligibility documents for the Hiring of Consulting Services to conduct survey works and preparation of corresponding survey plans for the abovementioned area as well as the establishment on the ground of boundaries (please refer to the Terms of Reference (TOR). Interested consultants must submit their eligibility documents on or before 27 October 2015 at 10:00 A.M. at HUDCC Conference Room, 15th Floor, BDO Plaza, 8737 Paseo de Roxas Avenue, Makati City. Applications for eligibility will be evaluated based on a non-discretionary "pass/fail" criterion.
- 2. The BAC shall draw up the short list of consultants from those who have submitted Eligibility/Expression of Interest and have been determined as eligible in accordance with the provisions of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act", and its Implementing Rules and Regulations (IRR). Bidder/s who have already submitted their eligibility documents on 30 September 2015 for the hiring of consulting services for four land subdivision surveys were no longer require to submit eligibility documents instead Letter of Intent/Expression of Interest for the said project will suffice.
- 3. The short list shall consist of five (5) prospective bidders who will be entitled to submit bids. The criteria and rating system for short listing are:

- 4. The proponent must pass the required minimum score of seventy per cent (70%) to be shortlisted.
- 5. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the IRR of RA 9184.

- 6. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines.
- 7. The HUDCC shall evaluate bids using the *Quality Cost Based Evaluation (QCBE)*.
- 8. The weights to be allocated for the Technical and Financial Proposals are as follows:

Financial Proposals	40%

- 9. The criteria and rating system for the evaluation of bids shall be provided in the Instructions to Bidders.
- 10. The HUDCC reserves the right to reject any and all bids, annul the bidding process, or not award the contract at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
